

TICKET CONDITIONS & INCLUSIONS

6. Participants will comply with Sharks' Kokoda travel conditions.
7. It is an essential condition of this agreement and of the right of participation on the Cronulla Sharks Kokoda Trek 2018 that participants agree:
 - (a) Not to resell or transfer the Travel Package;
 - (b) Not to use it for advertising, promotion, or other commercial purposes (including competitions and trade promotions) or to enhance the demand for other goods or services;
8. The Travel Package includes:
 - A four-week training program designed and run by the Sharks High Performance staff. Participants will have access to the Sharks training facilities to help prepare for the Trek.
 - As part of the Trek you will participate in Leadership training designed to increase your confidence, knowledge, and resilience. You'll also learn techniques for developing an unbeatable mind for mental toughness, facilitated by former Special Forces Sergeant and current Cronulla Sharks Football Operations Manager, Shane Smith (see Bio) and NRL Coach Shane Flanagan.
 - Eight (8) nights in Papua New Guinea with 2 night's twin-share accommodation.
 - All meals and transfers.
 - All international airfares and helicopter pickup.
 - Historical battlefield tour and visit to the Bomana war cemetery.
 - Local porter for carriage of extra equipment.
 - Personal tent (1 per trekker).
 - Public liability insurance cover.
 - Comprehensive travel insurance with Covermore.

RESPONSIBILITY AND LIABILITY REGIME

9. The Participant indemnifies the Sharks against any loss or property damage as part of the Cronulla Sharks Kokoda Trek 2018 and for any personal injury, death or loss of damage to any property or any person arising out of or because of its participation in the Trek except that such loss, damage, injury or death arises from the negligent act or the omission of Sharks.

CANCELLATION, REFUNDS & REPLACEMENTS

10. Once the form is sent to Sharks, the participant may cancel the order and refunds are allowed only as expressed in this Agreement.

PRIVACY AND GENERAL

11. Sharks respect the privacy of the individuals on who Sharks collects, uses and discloses personal information. A full copy of Sharks Privacy Policy can be found on the website www.sharks.com.au
12. Sharks may choose not to enforce a term of this Agreement in some cases in its absolute discretion without affecting its right to enforce that term in other cases, including by replacing tickets if the Participant can demonstrate proof of purchase and identity acceptable to Sharks.
13. These terms may be varied from time to time as notified on the Sharks website.
14. This Agreement:
 - (a) Is governed by the law applicable in the state of NSW and each party submits to the jurisdiction of the courts of that state; and
 - (b) Is the entire agreement between Sharks and participant in respect of its subject matter.
15. By completing this form, the participant agrees to receive marketing and promotional e-mails from the Cronulla Sharks.

DEFINITIONS

16. In this agreement:
 - Participant means the individual taking part in the Cronulla Sharks Kokoda Trek 2018.
 - Cronulla Sharks Kokoda Trek 2018 Travel Package means the flights, transfers, accommodation, meals and associated travel items for this opportunity.
